AssetfinX - Privacy Policy

This privacy policy and all claims and disputes (including but not limited to non-contractual disputes or claims) arising out of or in connection with your use of this website is construed under and shall thus be administered by the laws of the United States of America. It describes what information we collect about and from you, the manner in which we collect such information and how AssetfinX uses, shares, and protects your personal information when you use our services. You should not use or access our site if you disagree in any way with our policy.

THE INFORMATION WE COLLECT

At AssetfinX, we only collect personal information that is necessary for us to perform our obligations to you. The kind of personal information we collect from you is dependent on the kind of products and/or services that you request from us. This may include;

- a) information that you provide during the registration process including your name, address, contact details, email address, and other relevant identification documents;
- b) information you provide when you request a service from us; and c) pertinent financial information such as your financial position and other relevant information obtained from credit checks.
